2. Details

Eligibility Requirements

- Artists aged 24 or older
- Undergraduate students (currently enrolled or on leave) are ineligible; graduate students are eligible
- Artists demonstrating a commitment to experimental and creative artistic practice
- Artists who have applied for Palbok Art Factory residency within the last 6 years (2020–2025) are ineligible
- Residency period must not overlap with other residencies

Required Commitments

- Minimum 12 days/month in-studio presence
- Residency period must not overlap with other domestic or international residencies
- Donation of 2 works upon residency completion
- Donated works must participate in the final exhibition
- Consent to use artist profile and work photos for promotional purposes

Support Provided

- Private studio space
- Shared workspace, storage room, video room, kitchen/laundry/shower facilities
- Accommodation provided (utility fees borne by resident)
- Production of documentation video on artistic practice and activities
- Participation in final exhibition and production of exhibition catalog
